# **Engagement Towards Ending Canada's Discrimination** in First Nations Child and Family Services (FNCFS)

On August 20, 2025, the Canadian Human Rights Tribunal (Tribunal) issued 2025 CHRT 80, ordering Canada, along with the co-complainants in *First Nations Child and Family Caring Society of Canada et al. v. Attorney General of Canada*, to move forward on national FNCFS long-term reform without further delay. The order requires the parties to submit their remedies for national long-term

remedies for national long-term reform, created either separately or together, by December 22, 2025. This shall happen concurrently and separately from the Ontario long-term Final Agreement (OFA).

Since early October, engagement sessions have been held across the country to gather input from First Nations leadership, rights holders, technical experts, caregivers, and individuals with lived experience on a plan to permanently end Canada's discrimination. Over the next several weeks, engagement feedback will be carefully reviewed and consolidated into a plan, then submitted to the Tribunal.

On September 19, 2025, Canada filed a judicial review of 2025 CHRT 80. While the judicial review is ongoing, it does not suspend or alter the Tribunal's orders, nor

does it change the requirement for the parties to move forward with FNCFS long-term reform.

# Tribunal Grants Interested Party Status in OFA Proceedings to Two First Nations

The Tribunal continues to manage proceedings related to the OFA. In early February 2025, the Chiefs of Ontario (COO), Nishnawbe Aski Nation (NAN), and Canada released the OFA. On March 7, COO and NAN filed a joint motion with the Tribunal seeking the following: an order approving the OFA without condition; an order that the OFA and Trilateral Agreement Respecting Reform of the 1965 Agreement will satisfy, supersede, and replace all orders of the Tribunal related to its findings of discrimination; and an order ending the Tribunal's jurisdiction with respect to Ontario, except regarding Jordan's Principle. These actions prompted 14 First Nations to file motions seeking interested party status in the Tribunal proceedings.

In 2025 CHRT 85, the Tribunal granted interested party status to two of the First Nations that applied: the Taykwa Tagamou Nation and the Chippewas of Georgina Island. The Tribunal determined that these Nations offer distinct perspectives as Ontario-based communities directly affected by the OFA. Both Nations asserted that the OFA does not provide lasting reform, fails to address discrimination and funding inequities within FNCFS, overlooks certain remoteness challenges, and was developed without meaningful engagement. All parties are now working to finalize a schedule for submissions and hearing dates before the Tribunal.

### **Orange Shirt Day 2025**

On September 30, over 1,250 students, educators, and members of the public gathered at **Beechwood Cemetery and** 

in downtown Ottawa to honour Orange Shirt Day and the National Day for Truth and Reconciliation. The Caring Society was privileged to partner with the Assembly of Seven Generations (A7G) and Beechwood Cemetery to make this day of learning and action possible.

- School tours. Led by young people from A7G, the day began with over 300 students and educators embarking on walking tours at Beechwood Cemetery, where they learned about several key figures involved in the residential school system, the role of the federal government, and how we can learn from history to address contemporary injustices experienced by First Nations, Inuit, and Métis peoples.
- Art and letter writing at Action **Tables**. Led by students from St. Monica elementary school, participants had the opportunity to visit

four different action tables at Beechwood to write letters, paint tiles, blow bubbles, and creatively express their commitment to reconciliation.

 Special honouring. To honour the children who passed away at residential schools and their families, members of the public gathered at the Children's Sacred Forest at Beechwood Cemetery. Elder Barbara

> Dumont-Hill opened the honouring, and Brittany Mathews (Caring Society) and Josh Lewis (A7G) introduced former Commissioner of the Truth and Reconciliation Commission, Marie Wilson, and

former Northwest Territories Premier, Stephen Kawkfi, to share a few words. We were also honoured to have jingle dress dancer Dara Wawatie-Chabot and drummer Nimkeehns Wemigwans share a song.

• Public tours at Beechwood. In the afternoon, A7G members and Beechwood staff led public tours in English and French. We were also excited to partner with

Arran Mills to offer a tour with ASL interpretation.

 Public walking tours downtown. Members of A7G also led Reconciling History Walking Tours in downtown Ottawa, stopping at 15 sites along Sparks Street and throughout the Byward Market to provide participants with opportunities

to learn more about the role of the federal government and bureaucracy in the residential school system. We were honoured to have Anishinabe Odjibikan and Buffalo Cultural Collective provide cultural exhibits and teachings as part of the walking tour this year.

· Art exhibit. With thanks to Beechwood, an exhibit displaying artwork that engaged with the

Truth and Reconciliation Commission (TRC) Calls to Action, reconciliation, and truth telling was featured inside the Beechwood National Memorial Centre.

### **Update on Jordan's Principle Cases Before the Courts**

The Federal Court has issued precedent-setting decisions in cases relating to Jordan's Principle requests denied by Indigenous Services Canada (ISC). In both Cully v. Canada and Powless v. Canada, the Federal Court decisions affirmed that the Tribunal's orders limit ISC's discretion when determining Jordan's Principle requests. Further, the decisions confirm that ISC must implement Jordan's Principle broadly and in a manner that respects substantive equality, cultural

appropriateness, and the best interests

of the child.

Canada appealed the Federal Court's decision in Powless v. Canada, and the hearing took place on October 6 at the Federal Court of Appeal. The Caring Society and the Assembly of Manitoba Chiefs applied for and were granted interested party status for the appeal. Importantly, the Federal Court's decision stands, unless it is overturned by the Federal Court of Appeal.

The Caring Society has developed information sheets and resources in both French and English to assist families in learning about these important decisions and to share the avenues available when a Jordan's Principle request is delayed or denied.

# Senator Brian Francis Calls on the Senate of Canada to Recognize Bear Witness Day

Senator Brian Francis of Prince Edward Island has reintroduced a motion in the Senate to formally recognize Bear Witness Day!

Senator Francis is Mi'kmaw/Lnu from Lennox Island First Nation and a long-time supporter of Jordan's Principle. Most recently, Senator Francis joined with Senators Audette, Greenwood, Harder, Klyne, and White to honour the 20th anniversary of Jordan's Principle with a Bear Witness Day celebration for elementary and high-school students at the Senate of Canada, hosted in collaboration with A7G and the Caring Society.

Day, the Senate would take an important step to reaffirm its shared commitment to equity for First Nations children and to ensure that Canada properly implements Jordan's Principle. The step toward formal federal recognition of Bear Witness Day is particularly important given the ongoing lack of full implementation of Jordan's Principle by Canada. Senator Francis calls the motion a small but meaningful step toward recognizing Jordan's lasting impact, his family's extraordinary strength and advocacy, and all those who have worked to uphold the rights of First Nations children.

By formally recognizing Bear Witness

Senator Francis first introduced the motion in December 2024, but unfortunately, it did not proceed, due to the federal election. With the new government in place, Senator Francis is hopeful the motion will be debated and voted on before the next Bear Witness Day, which is on May 10, 2026.
