This brief letter is written on behalf of Nishnawbe Aski Nation ("NAN") and serves to update the Panel on an important development in the implementation of its orders regarding remoteness costs.

As indicated in my letter submitted May 31, 2021, Canada and NAN entered Phase 3 of the Remoteness Quotient ("RQ") work earlier this year. To date, Phase 3 has involved collaborative work between experts from each respective party, as well as non-technical meetings between the parties.

I am pleased to report that Terms of Reference for Phase 3 of the RQ work were executed in early August of this year. NAN and Canada agreed following the latest RQ Table meeting that these Terms of Reference should be shared with the Panel and parties. It is my honour to enclose with this letter the executed Terms of Reference for Phase 3 of the RQ Table's work.

I respectfully propose that a further update on the RQ work be provided in six months' time. In the meantime, NAN would be happy to respond to any questions the Panel may have regarding the Terms of Reference and Phase 3 work.
